Physical Exhibit:

- o Entire project is at or under the size restrictions (including table): depth – 2½ feet, width – 4 feet, height – 9 feet
- o Exhibit is not attached to the table or the wall

Research Notebook: The following items MUST be in the Research Notebook

- o Checklist for Adult Sponsor (1)
- o Student Checklist (1A)
- o Approval Form (1B)
- o Research Plan (not a form)
- o If applicable, Registered Research Institutional/Industrial Form (1C)

Items **NOT** Allowed for Display at Project or in Booth:

- o **Living organisms, including plants**
- o **Soil, sand, rock, and/or waste samples, even if permanently encased in a slab of acrylic**
- o Taxidermy specimens or parts
- o Preserved vertebrate or invertebrate animals
- o **Human or animal food**
- o Human or animal parts or body fluids
- o **Plant materials** (living, dead, or preserved) that are in their raw, unprocessed, or non-manufactured state (EXCEPTION: manufactured construction materials used in building the project or display)
- o All chemicals, **including water**
- o All hazardous substances or devices, including poisons, drugs, weapons, ammunition, reloading devices and class III and IV lasers
- o Dry ice or other sublimating solids
- o Sharp items, including syringes needles, pipettes, and knives
- o Flames or highly flammable materials
- o Batteries with open-top cells
- o Awards, medals, business cards, flags, logos, CDs, endorsements, and/or acknowledgments unless an integral part of the project
- o Photographs or other visual presentations depicting vertebrate animals depicting vertebrate animals in surgical techniques, dissections, necropsies, or other lab procedures
- o Active internet or email connections as part of displaying or operating the project
- o Prior years' written material or visual depictions on the vertical display board; Continuation projects must have a Continuation Project Form (7) vertically displayed
- o **Glass or glass objects unless deemed to be integral and necessary for project display**

Items ALLOWED at Project Display BUT with the Restrictions INDICATED:

- o Photography and image rules: 1) Not deemed offensive or inappropriate (note images of vertebrate animals depicting lab procedures, etc. are not permitted) , 2) Give credit to the line of origin ("Taken by..." or "Taken from..."), 3) From the internet, magazines, newspapers, journals, etc., and credit lines are attached, 4) Photographs or visual depictions of the finalist, 5) Photographs of human subjects for which signed consent forms are at the booth
- o Any apparatus with unshielded belts, pulleys, chains, or moving parts with tension or pinch points IF FOR DISPLAY ONLY
- o Any demonstration for judges or the public must be performed within the maximum project size noted above
- o Laser rules: Class II lasers are permitted IF output energy < 1 mW and is operated only by the finalist and only during Display and Safety Inspection and during Judging, enclosed in protective housing that prevents physical and visual access to beam, and is disconnected when not operating; Class III and IV lasers are permitted IF for display only and not operated
- o Any apparatus producing temperatures that will cause physical burns if inadequately insulated
